<u>Current Students</u>: Students who are currently enrolled have a permanent spot in their class, until a paid 4 week written taking a break notice is given. We reserve the right to drop a class from the schedule if less than three students are registered for that class. We may also add a class if more than three students request it and the staff and space are available.

Arrival and Picking Up Students: Be sure that your student arrives 5 minutes before (no earlier please) to his/her scheduled class time. Parents are required to stay in the building until the student is in class with the instructor. After that time, parents may leave the facility. Please pick up your student on time. If you know you will be late picking up your student, please notify us as soon as possible. **Instruct your student to wait inside the building and you should escort them from the building to your car especially when the parking lot is crowded.** Please take into consideration that our students may include young children. Please drive slowly and carefully. Do not take the chance on your student running to and from your car. Additional parking is located in the gravel parking lot across the facility.

What to Wear: Boys and Girls may wear tucked in T-shirts and shorts free of buttons or zippers. Girls may choose to wear leotards (no footed tights or jeans). All students will be bare foot for class. Tumblers may have the option to wear shoes for tumbling purposes. Street shoes are not permitted on the matted surfaces. Hair should be pulled securely away from the face so it stays up for the entire class. Girls should not wear bows or other large hair ornaments that may cause discomfort during activity. For Karate: Uniforms must be worn to all classes. PLEASE LEAVE JEWELRY ARTICLES AT HOME. This facility's staff will not be responsible for ANY items that may be lost or stolen. Be sure your student's personal items are marked with their name and are not left in cubbies during their class.

Registration Fees: All families will be charged an annual registration fee of \$24.00. This fee is good for one full year. Registration will be prorated at sign up. Annual registration fees will be due on January 1st of each year.

Payment of Fees and Discounts: Monthly fees are due on or before the 5th of each month. A \$10.00 late fee will be charged on all accounts if fees are not paid by the 5th of the month. All fees can be paid by cash, check, credit card, ACH Automatic payments from checking or savings and payments can be made online. If payment is not received by the end of the second week, your child's spot will no longer be reserved in the class in which he or she is enrolled and the balance will remain on your child's account. There will be a 10% discount off total family enrollment if your family is enrolled in two same or different classes. A discount of 15% off total enrollment if your family is enrolled in three or more same or different classes. Statements regarding the next month's tuition will be sent to your email on the last week of the current month. If you have signed up for Auto Pay this statement will show you what will be drafted on the 5th of each month. If you are not signed up for Auto Pay you may sign up at any time. This is done by submitting your checking account information or credit card information to the front desk or registering online through the Parent Portal. You may also cancel this service at any time.

<u>STUDENT FROM CLASS</u>. Only a written paid notice given to our front desk with advance payment will be accepted. Please Note: You are responsible for payment for your student's classes WHETHER OR NOT YOUR STUDENT ATTENDS CLASSS until the time you notify the front desk VIA WRITTEN NOTICE. Please do not rely on your student to verbally let us know that he/she will no longer be attending classes. If a student stops coming to class without notification then the student's account will be charged for the 30 additional days. This charge will be for holding the student's place in that class instead of offering that place to one of the many on the waiting list.

Refunds & Account credits: Will be given for extended illness or injury upon timely notification of the situation to the front office. If classes are missed for other reasons, you are responsible for arranging a makeup time with the front desk. Apparel will only be exchanged with proper tags.



Makeup Policy: It is best that your child attend class on a regular basis. Your account will not be prorated or adjusted for any missed classes because our staff is here to teach that class. If space is available, all students will be allowed to make up missed class within a 2 month window. After 2 months, you will not be able to reschedule those missed classes. You will receive an absence call or email from the front office the following day and you may reschedule at that time or the next time that you are present in the gym.

Open Gym and Open Karate: If your child misses a gymnastics, tumbling, or karate class they may use Open Gym or Open Karate as a makeup class at any time. Open Gym and Open Karate can be scheduled ahead of time or you may walk in. Please check in at the front desk as a make up. Open Gym and Open Karate are held on Fridays from 5:30-6:25. If your child would like to come to Open Gym or Karate for extra practice the cost is \$10 per visit and walk-ins are welcome. Children under the age of 5 are not permitted to use Open Gym for makeups. They may reschedule a makeup class in our Tumble Tots Preschool classes.

Snow and Inclement Weather: We do not follow a Putnam County school schedule for inclement weather. Should schools close due to bad weather, classes will still operate on a regular schedule. If the weather does cause the gym to close, it will be announced on local radio stations, on our website, Facebook and our answering machine message. Any closures for inclement weather can be rescheduled.

Gym Safety: If any child's participation in any way jeopardizes the SAFETY of that child or other children and staff you may be recommend and given the opportunity to reschedule. Only students and staff are allowed in the gym area! Students must wait behind the wall for their instructor before getting on any equipment in the gym. This includes the floor exercise mat. For the safety of your child and others in class, please keep children from playing or anyone sitting on the wall. No running and playing will be allowed in the upstairs parent viewing or on the stairs.

<u>Students with Special Needs</u>: Children with special needs are welcome! We request that all parents communicate <u>any</u> unique needs that your child may have so that we may make the staff knowledgeable. Class enrollment requests for special needs children require a Student Evaluation before being able to be placed in class. Student class evaluations are \$35 and can be scheduled with our Directors of Special Needs. This evaluation will determine if your child needs to be paced in a class that will be more catered to the child's needs.

Gym Closures: VSC operates on a 48 week yearly calendar as opposed to a 52 week year. Therefore, there are 4 weeks out of the year the gym will be CLOSED and no makeups will be given. These weeks are as follows: One week during Spring, One week during Summer, One week during Fall and One week at Christmas. If the gym is closed any other time (Ex: Labor Day, Good Friday) you may schedule a makeup class for your child at your 2 month time period with the front desk at your convenience.

Food and Beverage: No food, beverages or gum is allowed on the gym floor.

Smoking: Smoking of any kind will not be permitted any where in the facility.

Advertising: Occasionally, Victory Sports Center will take photos of the gym and classes for promotional purposes. Photos taken for advertising and promotional purposes may include your children. Victory Sports Center may use these photos with no compensation to you or your child.
