VICTORY CAMPS DISCIPLINE METHODS: During the hours that your child will be at any of the camps we enforce the 3 Strike System for Discipline. **Our 3 Strike Method is:**

Warning- Verbal warning to stop the problem (up 2 times)

1st Strike- Given to child after verbal warnings were not heeded; time out or sit out of game

2nd Strike- Due to continued action or behavior your child will be sent to Director to discuss the problem, why it is happening, what can fix the problem, and any consequence for continuing bad behavior/action

3rd Strike- Call to parents to discuss behavior or actions problem; can lead to grounds of dismissal for the current camp day or suspension from other camp days.
