PAYMENT POLICIES

_____ All families will be charged an annual registration fee of \$24.00. This fee is good for one full year. Registration fees will be pro-rated upon sign up. Annual registration fees will be due January 1st of each year.

_____ Payment for a monthly tuition of classes must be made by the 5th of each month.

_____ In the event a payment is made after the 5th, a charge of **\$10.00** will be added to your account as a late fee. At that time, a bill will be sent to your address.

_____ If your account is not current by the end of the second week of classes, your child will be dropped from classes.

_____ A **\$25.00** returned check fee (per check) will be added to your account in the event that your check is returned to us.

_____ If you feel that you have been charged incorrectly, DO NOT adjust your payment without making arrangements to do so with our front office. You will not receive a refund for absences, but we do have a make-up policy.

_____ **In the event that you wish to cancel your enrollment in our program, you will be required to submit a withdrawal notice with payment to the front office 30 days before your withdrawal date.**

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")
